WHAT TO EXPECT AT THE JANUARY 12th ZOOM MEETING

You can connect with your laptop, computer, iPad, or phone. The very nicely shortened address: https://bit.ly/WHDNA-01-12-2023 is most welcome. Type it in a few minutes prior to meeting start time (6:30 pm), settle back and see what you can learn and to whom you can turn. We have two programs, one from CCSO and one from the Commission on Aging (see page two).

There's a new Sheriff in town! Clark County Sheriff's Office ("CCSO") top officer is newly elected **John Horch.** He has spoken with neighborhood associations in the past as a busy deputy handling all manner of positions. Now we are proud to call him "Sheriff Horch."

Remembering that it's his first couple of weeks in office, we should still be able to inquire of his plans for the department going forward. Personally, I'm curious about the possibility of a law enforcement training facility being brought to our area. I've also received calls about vehicle thefts, graffiti at or around schools and businesses, as well as thoughts on initiating a "NOW" (Neighbors on Watch) program, similar to what the City of Vancouver offers. At the last "NUSA" (Neighborhood Council of the United States of America), there were reports from multiple cities using the program with great success. Vancouver's police department was one of those reports and it demonstrated impressive successes. Bring any questions you might have for Sheriff Horch about what's happening around your area.



If you live within the West Hazel Dell Neighborhood Association ("WHDNA") boundaries, you are a "member" of our neighborhood association.

WHDNA now has slightly adjusted **boundaries**. We still begin on the southern and western sides at the Vancouver city limits; on the north we go to NE 104th Street, NE 11th Avenue and NE 99th Street; on the east we now stop at I-5.

That adjusts our voting districts as well. We have added 212 residences to District 1 and 1,794 to District 2. WHDNA now provides liaison services to 7,231 homes. Welcome to all the new West Hazel Dell NA neighbors.

To make the association work for everyone, we need input, good or bad; it all helps us get a handle on things. Currently, we are asking for volunteers to serve on our board and others who could act as conduits for the widespread areas of West Hazel Dell NA boundaries. Please contact me if you are interested in seeing WHDNA continue to thrive. You are needed!

Aging Readiness Plan Update

The Clark County Aging Readiness Plan assesses the county's readiness to serve as a home for a growing number of older residents. The plan includes strategies to improve the community's capacity to support its growing older population and ultimately benefit people of all ages. The plan covers the topics of housing, transportation/mobility, health care, support services, and civic activities. Susan Ellinger and Jenna Kay are the principals on this project and will be at our Zoom meeting on Thursday, January 12th to tell us more about it.

The Commission on Aging is updating the Aging Readiness Plan and wants public feedback to help assess implementation to date, refine existing strategies, brainstorm new ideas for the updated plan, and guide the creation of a new chapter focused on emergency preparedness.

A message from your president:

Our neighborhood association ("NA") now includes over 7,231 homes; about 20,000 people. It's quite a diverse area. It is difficult to know what our community members want to know about, let alone what their problems might be. As a neighborhood association, our power is in our people and we have a voice. Our concerns need to be put forward to our county councilors and/or agencies so they can be acted upon. They can't fix what they don't know about. We have three new councilors and our area includes two voting districts so both **Glen Yung** and **Michelle Belkot** represent us. **Sue Marshall**, new District 5 councilor, is also a great resource.

WE NEED TO ADD MEMBERS TO OUR BOARD and this is the time to do it. Our new Bylaws have been approved so that's one task done already. Board members are unpaid volunteer positions. The board can consist of as many wonderful neighbors as want to help out. We are not presently a 503(c)(3) tax exempt association. So currently any money given to any WHDNA events is a *donation* and not tax exempt. The board members can decide how often they meet, bimonthly or quarterly for an hour or two to determine topics for the bimonthly NA meetings.

We have residents from all over . Yet, there is no representation of any of those cultures in our NA footprint. I think that is really sad, but without neighbors stepping up to spend a little time meeting and bringing issues and information forward, those diversities remain untapped. That is a loss to us all. I will welcome anyone who is interested in seeing WHDNA continue to thrive. Clark County Outreach Office and Print Shop prints, mails and/or posts our newsletters and provides a NA listing on its website. Now we have our own website, too. We just need people.

Your WHDNA continues to have representation at the Neighborhood Association Council of Clark County ("NACCC") monthly meetings. I am the vice-chair of NACCC and recognize its value. If you are interested in sitting in on a NACCC Zoom meeting, please drop me a note and I will forward an invite your way. **NACCC** meets the <u>second Monday</u> of each month (holiday or not) from 7:00-8:30 pm. The neighbors who have attended have come away with a better understanding of what other Neighborhood Associations ("NAs") in our county are dealing with. Many of the concerns are shared county-wide. **More voices equal more impact**.
