Statutory Provisions

This Voter Challenge Summary and accompanying Due Diligence materials are presented alongside the sworn Voter Challenge Form Affidavit and with reference to RCW 29A.08.810(1)(c)(ii)(A) – (E).

I personally have undertaken the research and compilation of the Due Diligence materials and have personal knowledge of each independent item of Due Diligence herein, having gained such knowledge by performing actions myself (e.g., preparing/mailling letters and querying online databases as required) and via others (e.g., tracking letters handled by the US Postal Service, contacting Clark County staff regarding property ownership, obtaining canvasser/occupant affidavits). This Challenge is not based upon unsupported allegations or allegations of anonymous third parties. It is noted hearsay evidence is admissible in support of this Challenge (Ref. RCW34.05). Having exercised Due Diligence to personally verify the evidence presented on information and belief, the following is the factual basis for the Voter Challenge:

1. **a. Washington Secretary of State (SOS) Voter Registration Database (VRDB):** Lauren Marston, the above-listed voter, is identified as living at residential address 1105 SE 104th Avenue, Vancouver WA. She has never voted. Research support confirms that she does not reside at the VRDB residential address. **See attached.**
- b. Oregon Secretary of State (SOS) Voter Registration Database (VRDB):** Lauren Marston, the above-listed voter, has been registered to vote since 2013. She is identified as living at residential address 10111 SE Lexington Street, Portland OR. She has not voted. Research support confirms that she does not reside at the VRDB residential address. **See attached.**
2. **Affidavit from Current Resident:** An affidavit was obtained from a nearby neighbor in Vancouver who verified that Lauren Marston does not currently live at 1105 SE 104th Avenue. **See attached.**
3. **Certified Mail Receipt:** A required attempt was made to contact Lauren Marston at the registered mailing address in Vancouver via a letter and a USPS certified mail receipt with a request to update her residential address. **See attached.**
4. **Search People Free:** Website <https://www.searchpeoplefree.com/> indicates that Lauren Marston has a current mailing address at PO Box 185, Seward AK 98664. Multiple numbers for her are listed. **See attached.**

5. **Cyber Background Checks:** Website <https://www.cyberbackgroundchecks.com/> indicates that Lauren Marston has a current mailing address at PO Box 185, Seward AK 98664. Multiple numbers for her are listed. **See attached.**
6. **GIS Property Tax Records:** Lauren Marston does not own any property in Clark County per Carmen at the Treasurer's office.
7. **Voter Registration Verification:** Website <https://voteref.com/voters/> indicates Lauren Marston is currently registered to vote in TWO STATES:
 - a. **WASHINGTON** - 1105 SE 104th Avenue, Vancouver WA. **See attached.**
