Ad Hoc Committee: Pursuant to Section 4.0 of Law and Justice By-laws

Goal: To have a holistic, functional and sustainable approach to law and justice, ensuring public safety needs are met in the community.

Background:

- City of Vancouver Proposition
- Clark County Sheriff's Office Requests
- Law and Justice Regional Stakeholders



Requests:

- 1. City of Vancouver and Sheriff's Office to provide an overview of their recommended public safety initiatives to the Ad Hoc Committee, to include:
 - Additional staffing
 - Additional programs
 - Anticipated capital needs
 - Financial impacts (expenses and revenue streams)
 - Anticipated timeline for implementation



Requests:

- 2. Commence an Ad Hoc Committee with representation from all regional law and justice stakeholders, as well as financial representation from the county, to review the City and County's law enforcement request and outlined the following:
 - Specific data articulating the department/office impacts per one (1) additional officer/deputy.
 - Total impacts (e.g. total staff, costs, capital, etc.) if the City of Vancouver proposition is successful.
 - Total impacts (e.g. total staff, costs, capital, etc.) if the Sheriff's Office potential proposition is successful.
 - Potential revenues sources and amounts.



Requests:

- 3. Provide a recommendation to the Law and Justice Council.
- 4. Provide a recommendation to the legislative body of applicable jurisdictions (e.g. Clark County Council).



KO's Key Takeaways

- Law and Justice Partner discussion and collaboration added value and will continue.
- This type of review is unprecedented in the state.
- Very preliminary information will adjust as impacts are assessed.
- CoV confirmed cost allocation only incorporates 6211 billing which does not include any funding for felonies, which are more than 90% of those housed in the jail.
- Anticipated costs includes anything that may be billed through 6211.
- Traffic camera program may have significant impact on District Court.
- Additional law enforcement doesn't mean additional high-level crimes such as murder.
- Overtime is impacting people on a critical level across the board Law Enforcement, Juvenile Detention Officers, Corrections Officers, etc.
- Countywide Law and Justice services are essential in supporting public safety, and is currently not sustainable.
- Data is important!
- Collaboration is important!
