Non 2022, Clark County a kan napeno sakopaten aramas seni nupwen a kan non 2019. Non 2022, ewe mwichen (resapw-Hispanic) repwech a kan forata 75% seni ewe unuseñ chon non awewe ngeni 77.3% non 2019. Nefinen 2019 me pwan 2022, ewe wukukun ren ewe unuseñ chon nom non ina ra kan Hispanic/Latinx a kan ewe a fokkun napeno maritan, anapeno 1.1 pesent points ngeni 11.4%.




**Figure 1. Ierir**




**Figure 3. Sakkun aramas**

**Figure 4. En seni ia **



Meta ewe tekian awukukun eom sukun en ka kan angeieno? / 713 ponu ngeni kena







Meta we saisin eomuna family? / 744 ponu kena










**Figure 10. Insurens**



Fitomen chon non family kena ra kan angang? / 596 ponu ngeni kena




**Figure 13. Nenien Angei Monitonong**







Meta usun eomuwe ususun imweimwom non ei attun? / 718 ponu kena




**Figure 16. Zip Code**

Meta eomuwe zip code iei ika ewe nasenon ra sinei? / 709 ponu ngeni kena




**Figure 17. Mapen Zip Code**






**Figure 19. Mwichen Nenien Nonom ren Sakopaten Mwichen Aramas kena**
















**Figure 24. Mochenin angangen aninisin angang kena**














