Firework Law RCW Title 70

Revised Code of Washington (RCW) Title 70 Chapter 70.77.250 (4):

"The chief of the Washington state patrol, through the director of fire protection, shall adopt those rules as are necessary to ensure statewide minimum standards for the enforcement of this chapter. Counties and cities shall comply with these state rules. Any ordinances adopted by a county or city that are more restrictive than state law shall have an effective date no sooner than one year after their adoption."



Title 5 Legal Discharge Times

Firework sales are regulated by Clark County Code Title 5 Chapter 5.28

It's impossible for us to know how many fires were the direct result of fireworks but it's safe to assume most of them were.



Understanding Call Volume

Any given fire event usually involves more than a single caller. CRESA is unable to accurately capture those figures. Each fire event generally results in 10-30 calls per incident – usually all within a 30-60 seconds.




2025 Firework Data

Clark County Fire District 3




A total of 16 fireworks violations were documented:

- 12 warnings issued
- 3 incidents with no responsible party found
- 1 citation for reckless endangerment

Most violations involved discharge outside legal hours or reckless use of fireworks. No use of illegal fireworks was directly observed.



Clark County Fire District 3 continued

Fire District 3 responded to (9) fire-related incidents from July 1 through July 7. Of these, (8) were in the city limits of Battle Ground.

- 8 fire calls
- 1 explosion
- No injuries reported
- 62,040 sq. ft. burned (1.42 acres)
- Estimated property damage: \$200 (burned fence)
- No structure fires reported.





Clark County Fire District 6
