### **Celebrating 2024: A Year of Remarkable Achievements**

As 2024 ends, we celebrate a year of teamwork and achievements. Key highlights include fully implementing tax increment financing (TIF) legislation, hosting a successful state conference, allocating over\$40 million in investment interest earnings (a record), and saving \$30 million in county General Fund through strategic capital financing. Additionally, we received State Auditor recognition for our manual tax receipting process implemented during a cybersecurity outage. It really helped that we were fully staffed office throughout the year.

#### 2024 Fast Facts:

- Assisted over 13,000 customers by phone.
- Processed over 70,000 bank transactions totaling \$9 billion.
- Achieved 98.4% customer satisfaction rating in the tax services division from over 350 surveys.
- Completed over 13,700 Real Estate Tax Affidavit transactions.
- Reduced foreclosures to just eight properties, thanks to proactive efforts.
